



SUBJECT: Coverage of Housing-Related Activities and Services for Individuals with

Disabilities

This Informational Bulletin is intended to assist states in designing Medicaid benefits, and to clarify the circumstances under which Medicaid reimburses for certain housing-related activities, with the goal of promoting community integration for individuals with disabilities, older adults needing long term services and supports (LTSS), and those experiencing chronic homelessness¹. Consistent with statute, CMS does not provide Federal Financial Participation (FFP) for room and board² in home and community based services, ³ but can assist states with coverage of certain housing-related activities and services.

This Bulletin underscores CMS' commitment to help states expand home and community-based living opportunities consistent with the Affordable Care Act, the implementation of the Home and Community Based Services (HCBS) settings final rule governing Medicaid's 1915(c) HCBS Waiver program, 1915(i) HCBS State Plan Option, and 1915(k) Community First Choice State Plan Option', as well as the Americans with Disabilities Act and the Supreme Court's decision in Olmstead v. L. C.⁵ The information in this Bulletin is based on evidence from studies demonstrating that providing housing-related activities and services facilitates community integration and is cost effective. This Bulletin is also intended to help states design benefit programs that acknowledge the social determinants of health, and contribute to a holistic focus on improvement of individual health and wellness.

Describing Housing-Related Activities and Services

Most broadly, housing-related activities include a range of flexible services and supports available to individuals with disabilities and older adults needing LTSS, as well as collaborative efforts among key Medicaid and housing agency staffs and stakeholders. In recent years, the

The CMS sees these services as "Home and Community Based Services".

Approved waivers and SPAs in FL, HI MN all require the states to structure tenancy support services into the state's existing HCBS infrastructure.


Room and board also includes capital funds used for new construction or rehabilitation of housing.

Is my state covering Housing Related Services?




HR 1Key Provisions Impacting Medicaid

Seven major provisions make up almost \$1 trillion of cuts and 7.5 million people are expected to lose health insurance coverage over the next 10 years.

Enrollment & Eligibility

Finance and Payment







HR 1 & Home and Community Based Services

- HR 1 eliminated the federal NFLOC requirement to qualify for HCBS, allowing states to define alternative eligibility criteria
- Historically, HCBS eligibility required individuals to meet NFLOC criteria to receive services in community settings instead of nursing homes
- Implications: expanded access, state flexibility
- Potential challenges: budget pressures

HCBS Basics

- Medicaid Long Term Support Services
 - Nursing Homes (mandatory)
 - Home and Community Based Services (optional, 47 states and 250+ waivers)
 - 1915i (statewide)
 - 1915c (limited eligibility but expanded under HR1)





Additional criteria for new HCBS authority under H.R.1

This new standalone waiver request is for 3-year period with additional 5 years at state request: HHS cannot approve a state request before July 1, 2028, but states will be developing long before that date.

Average wait time to receive HCBS must not be longer than under other approved waivers.

State must establish needs-based criteria that are no more stringent

Benefit must be cost neutral as compared to the average per capita cost of individuals receiving institutional care.

What's Involved in an Individual Accessing HCBS

Eligibility Determination

Often done by the state or a state defined, limited group of agencies focused solely on assessment

Financial, Diagnostic and Functional Limitations

Annual eligibility review

Person Centered Plan

Conflict Free Case Management

Service Coordinator like role

Referral to specialized providers/services

Update plan annually

Service Delivery

Housing or Tenancy Supports

SH partners may offer other services or regularly partner with agencies for

Key HCBS Services

Personal care assistance (bathing, dressing, eating)

Home health care (nursing, OT/PT therapies)

Respite care for caregivers

Transportation

Meal delivery


Case management/Care coordination

Environmental modifications

Assistive Technology

Services that secure and/or maintain housing

Behavioral support services


Recommended Actions

- Engage with state coalitions that work for better access and care for Medicaid recipients.
- Engage with your state Medicaid agency to advocate for new 1915(c) waivers with expanded eligibility for individuals who have experienced homelessness
- Help state identify a manageable pool of eligible people; help state with accountability measures to ensure quality and prevent fraud, waste and abuse.
- Monitor CMS guidance and state-level implementation plans to ensure equitable access and quality standards
