



# Learning Collaborative Call for Applications - 2019-2020 Capital Expansion for Health and Housing Partnerships

CSH (Corporation for Supportive Housing) and Capital Link are launching the third installment of our learning collaborative for health centers interested in expanding their health services in collaboration with housing partners. Over 30 health centers have participated in prior years and gained expertise in facility planning, health center and housing partnerships, and capital funding. These facility collaborations enhance health centers' engagement in Social Determinants of Health and advance efforts to expand a community's housing and health center infrastructure to meet growing demand.

The *Capital Expansion for Health and Housing Partnerships Learning Collaborative* will serve as a forum for a peer group of health centers to exchange expertise and solutions to challenges related to capital development expansion for housing and health center providers. Through a series of webinars and virtual discussions, facilitated by CSH and Capital Link from January through March 2020, we will explore the benefits of co-locating health center and housing facilities, relationship building with housing providers, capital expansion planning for coordinated facility expansions, assessing market needs, leveraging resources, and more.

The introductory webinar on Tuesday, December 3, 2019 at 1PM Eastern Time will provide an overview of the *Capital Expansion for Health and Housing Partnership Learning Collaborative.* 

#### Benefits of a Learning Collaborative

- Dynamic virtual peer dialogue
- Problem solving with stakeholders with similar objectives
- Subject matter experts respond to your issues and questions

*Group Learning*: Through a series of four virtual meetings/webinars, health centers will learn the basics of partnership building, capital planning, financing, and project development.

Individualized Planning Services: Each Learning Collaborative session will include exercises and planning templates that participants can adapt for their individual organization, partnerships and projects. In addition, individualized guidance, including office hours, from CSH and/or Capital Link will be available to help the participating health centers connect the materials for their own project planning and financing.

#### How Can We Participate in the Capital Expansion Learning Collaborative?

Health centers in the preliminary stages of partnership and capital project development will benefit from the shared insights of health center leaders who have taken on, or are embarking on, a range of capital projects to address the social determinants of health. It is the expectation that most participants will make significant progress towards readiness for planning a capital development project.

CSH and Capital Link will accept applications starting in November 2019 with the goal of 10-15 health center teams participating in the learning collaborative. Team enrollment is recommended with three individuals per organization including staff with executive, clinical, and outreach/enabling service responsibilities. Additional staff and partners can join sessions depending on the specific topic area. All interested organizations must:

- 1. Complete and return their "Application of Interest" by Friday December 13, 2019
- 2. Commit to engage in all Collaborative sessions and exercises with the goal of incorporating new knowledge towards their community collaborations and facility expansion plans.
