

CSH Donor and Web Privacy Policy

CSH is a national nonprofit organization whose mission is to help communities create permanent housing with services to prevent and end homelessness. In each of the communities in which we work, CSH serves as both a catalyst, bringing together people, skills and resources, and as a thought leader, designing new programs and policies, creating demonstration models, educating the public, private and nonprofit sector and serving as a leading national advocate for supportive housing.

We are committed to protecting your privacy. To enhance your experience on our website, csh.org (the "site") and to gather some information about the kind of visitors using our website, we occasionally ask for information about you. Below, you will find descriptions of the instances when the website requires and/or requests information from you, and how this will benefit you. This policy also outlines our donor privacy protocols that enable you to securely and confidently offer your support of CSH.

This Privacy Policy applies to all information received by CSH, both online and offline, on any Platform, ("Platform", includes CSH's website, mobile applications, and social media), as well as any electronic, written, or oral communications.

Registration

Registration is not necessary on this Site.

Email Alerts and Notifications

You have the opportunity to receive email alerts, e-newsletters and notifications about important news and information from CSH. If you opt in to this service, we will need to know your name, email address, phone number, address as well as some pertinent information about your interests, organizational affiliation and the type of information you would like to receive. As with all information we collect from you, we will never sell this information to anyone without your consent. Disclosure

We will not sell any information collected on our website. However, we may share a mailing list with other partners in the community development industry. This is never done without your ability to opt out or otherwise offer your prior consent. We do reserve the right to release information you have submitted with law requires such release.

Usage Data

We currently use a tool called Google AnalyticsTM to collect information about use of our Site. Google AnalyticsTM is described as "a web analytics tool that helps website owners understand how visitors engage with their website. Google AnalyticsTM collects information anonymously. It reports website trends without identifying individual visitors."

Google Analytics[™] uses first-party cookies to track visitor interactions. Cookies are small files stored on the hard drive of your computer. This file only identifies your computer to the Site enabling our Site to recognize you when you return to the Site so that it can remember your preferences and personal settings. Browsers do not share first-hand party cookies across domains.

Google's ability to use and share information collected by Google Analytics[™] about your visit to our website is restricted by Google Analytics[™] Term of Use and Google Privacy Policy respectively.

This Site contains links to other websites. We are not responsible for the privacy practices or the content of such websites. See note below about link to Network for Good and their privacy practices.

Our Use of Information

By providing information about yourself or your organization on our Site, you are giving consent to us to use this information internally. We reserve the right to change our policy. If our policy should change regarding the use of this information, it will be posted in this privacy statement.

Surveys

From time-to-time, our Site requests information via surveys. Participation in these surveys is completely voluntary and you may choose whether or not to participate and therefore disclose this information. Information requested may include contact information (such as name and shipping address), and demographic information (such as zip code, age level). Contact information will be used to offer gift cards or other nominal compensation for survey participation. Survey information will be used for purposes of monitoring or improving the use and satisfaction of this Site and/or more broadly informing the field of supportive housing as in the Annual State of the Industry Survey.

Donor Specific Policies

CSH maintains the highest respect for the privacy of our donors. CSH does not sell, trade, rent or share our donor list with any other organizations. Nor does CSH send donor mailings on behalf of other organizations.

CSH collects and uses personal information from its donors that includes: donor name, address, telephone number, email, amount donated, dedication, use restrictions or designations, and donor comments. Provision of telephone number, email and address are optional. Tax laws require CSH to keep contact information and contribution levels of donors on file. CSH uses donor information for the following purposes ONLY:

- Distribution of receipts for donations
- Thanking donors for their contribution
- Communicating donors about our work and invitation to events as appropriate
- Internal analysis and record keeping
- Reporting to relevant US and state agencies as required by law (these reports are not for public inspection)
- Contacting donors to invite new contributions
- Informing donors of any changes to the privacy or gift policy

Access to donor financial information is strictly limited to the professional staff that processes that data.

• Notice of contribution on website and in annual report

CSH wants to recognize our supporters and partners. Therefore, we post a listing of our supporters on our website. This recognition is also given in our annual report which is posted online. You may notify CSH if you want your information to remain private or be listed as anonymous. To opt out of being listed, simply contact CSH at info@csh.org

• Solicitation – Opt-Out Option

Occasionally (once or twice a year), CSH will send out email or hard mail solicitations for support from individual donors based on past contribution or otherwise identified interest. If you do not wish to be contacted for this purpose, you can let us know at <u>info@csh.org</u>

• Anonymous Donor Status

CSH respects any donor that wishes to remain anonymous in their support of our work. If you provide an indication with your donation that you seek to remain anonymous, CSH will not publish your name or affiliation on our website or in any documents. We will, however, maintain your information in our donor database for tracking purposed and any stewardship that may be required.

• Third Party for credit card processing

CSH does not process any credit card information via our website. In the case of donations, the website has a link to secure sites, including our primary on-line donation portal through Network for Good. Donations made through Network For Good, Inc. – including any donations made to charities other than Charity Navigator – are subject to Network For Good's privacy policy, which states in part: "Network for Good respects and protects your privacy and will never sell, trade or rent your personal information to other individuals or companies.
