## Family Unification Program

Special purpose Housing Choice Voucher program administered by a Public Housing Authority (PHA), in partnership with Public Child Welfare Agency (PCWA) and Continuum of Care (CoC).

#### **FUP** is designed to serve:

**Families** for whom the lack of adequate housing is a primary factor in:

- ☐ The imminent placement of the family's child or children in out-of-home care, OR -
- ☐ The delay in the discharge of the child or children to the family from out-of-home care.

#### Youth/young adults ages 18 to 24 who:

- ☐ Left foster care at age 16 or older, or will leave foster care within 90 days, and
- Is currently or at risk of experiencing homelessness.





## Foster Youth to Independence

Special purpose Housing Choice Voucher program administered by a Public Housing Authority (PHA), in partnership with Public Child Welfare Agency (PCWA) and other entities such as Continuum of Care (CoC).

#### FYI is designed to serve youth/young adults ages 18-24 who:

- ☐ Left foster care at age 16 or older, or will leave foster care within 90 days, and
- ☐ Is currently or at risk of experiencing homelessness.


